


Fig. 1 - Forward Current vs. Ambient Temperature




Fig. 4 - Relative Intensity vs. Wavelength




Fig. 2 - Forward Current vs. Pulse Length




Fig. 5 - Forward Current vs. Forward Voltage




Fig. 3 - Relative Luminous Intensity vs. Angular Displacement




Fig. 6 - Relative Luminous Intensity vs. Forward Current






Fig. 7 - Relative Luminous Intensity vs. Ambient Temperature






Fig. 8 - Forward Voltage vs. Ambient Temperature





PACKAGE DIMENSIONS in millimeters














Fig. 9 - Vishay Lead (Pb)-free Reflow Soldering Profile (according to J-STD-020C)





Fig. 10 - Double Wave Soldering of Opto Devices (all Packages)



DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



FINAL PACKING

A cardboard outer box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:


- Storage temperature 10 °C to 30 °C
- Storage humidity ≤ 60 % RH max.

After more than one year under these conditions moisture content will be too high for reflow soldering. In case of moisture absorption, the devices will recover to the former condition by drying under the following condition: 192 h at 40 °C + 5 °C / - 0 °C and < 5 % RH (dry air / nitrogen)

96 h at 60 °C + 5 °C and < 5 % RH for all device containers or 24 h at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC standard JESD22-A112 level 2 label is included on all dry bags.
